SDVMA Holds Annual Meeting and Recognition of Members

Dr. James Bailey receives Distinguished Service Award - Dr. John Ismay named Veterinarian of the Year

The South Dakota Veterinary Medical Association held its 123rd Annual Meeting at the Ramkota Convention Center in Sioux Falls August 10th – 13th. The meeting included continuing education opportunities for nearly 200 veterinarians and veterinary technicians, recognized outstanding accomplishments by professionals in the veterinary fields, and included the annual membership meeting.

The meeting featured sessions on companion animal, food animal, equine medicine, and regulatory health, including case reports from SDSU Animal Disease Research and Diagnostic Lab faculty involving current animal disease issues.

Dr. Bailey Receives Distinguished Service Award

The Distinguished Service Award is awarded to honor an individual who has brought distinction to the veterinary profession through his/her devotion to the care and well-being of animals, support for the profession, and

contributions to the community. This individual exemplifies the profession, both personally and professionally, through support of veterinary medicine, research, colleagues, and/or students and through civic participation. This individual's contributions have advanced the profession and serve as an inspiration to veterinarians and the clients he serves.

The recipient of the 2014 Distinguished Service Award was Dr. James Bailey of Brookings. Dr. Bailey's imprint and impact on veterinary medicine spans decades. He received his veterinary education from Iowa State University. In 1968, Dr. Bailey joined the SDSU faculty as the Extension Veterinarian. He retired in 1985 and was granted the status of Extension Veterinarian Emeritus. He served as the SDVMA Secretary/Treasurer from 1972-1985, and was the Executive Director of the SDVMA from 1985-1996.

Dr. Bailey's distinguished career includes numerous accomplishments.

In 1969, Bailey was one of the original Extension personnel to compile the fact sheets that became the present Pork Industry Handbook. He



contributed information on respiratory diseases and arthritis in swine. He was honored by the American Association of Extension Veterinarians as the Veterinarian of the Year; and also received the SDVMA Veterinarian of the Year award in 1977.

He served on the South Dakota Hog Cholera and Pseudorabies Eradication Committees. He was a member of the South Dakota Livestock Foundation from 1970-96. He served on



the Livestock Conservation Institutes Parasite Committee from 1979-81. Dr. Bailey received the South Dakota Pork Producers Council Distinguished Service Award in 1976 and was named an Honorary Pork Producer.

Dr. Bailey was a charter member of the American Association of Swine Practitioners in 1969. He served as the organization's first secretary in 1972 and as the president in 1980-81. He was granted the distinguished Howard Dunn Memorial Award for extraordinary service to veterinary medicine and the swine industry in 1986.

Dr. Bailey served as a member of the American Veterinary Medical Association's House of Delegates through the 1970's and on the Council on Biologics and Therapeutic Agents during the 1980's. Iowa State University College of Veterinary Medicine presented Dr. Bailey the prestigious Stange Memorial Award for distinguished alumni in 1984.

He was an instrumental part of the beginning of the annual Herd Health Conference at SDSU, which was first held in 1988. In 1997, the conference was renamed the James Bailey Herd Health Conference in recognition of Dr. Bailey's contributions to veterinary medicine in South Dakota.

Dr. Bailey and his wife Roberta live in Brookings. They have 5 children, 10 grandchildren, and 8 greatgrandchildren.

Dr. Ismay named Veterinarian of the Year

Dr. John Ismay of Sturgis was honored as SDVMA's Veterinarian of the Year. This award is made annually to an SDVMA member who has



contributed significantly to the veterinary profession and to the animals and clients he serves. The award recognizes a member for service and accomplishments benefitting the profession of veterinary medicine.

Dr. Ismay, a native of southwestern Colorado, graduated as a Doctor of Veterinary Medicine from Colorado State University in May of 1971. He received a Bachelor of Science degree from Colorado State University in 1969 with a minor in Chemistry.

In 1972, he purchased the Sturgis Veterinary Hospital. Seeing the need for a specialized referral center, he continually improved his clinical skills through advanced courses in medicine, surgery and dentistry both in the United States and abroad, surrounding himself with highly skilled specialists and investing in advanced technology. Over the years, with the dedication of a loyal staff, he developed the facility into an equine and companion animal referral center.

Dr. Ismay has published in both lay and scientific publications with some of the work being published in surgery text books. He holds a patent on a surgical procedure to remove Uroliths (stones) from the equine urinary bladder.

Dr. Ismay's special interest is in equine medicine and surgery and equine dentistry. He is a member of the American Veterinary Medical Association, South Dakota Veterinary Medical Association, Wyoming Veterinary Medical Association, and the American Association of Equine Practitioners. He has served on the American Association of Equine Practitioners Educational Programs Committee, Executive Committee of Veterinary Management Group 11, and Advisory Council for a large veterinary medical company.

Dr. Ismay and his wife Bonnie have two children and 8 grandchildren.

Dr. White Receives Emerging Leader Award

The Emerging Leader award is made to an SDVMA member who

graduated from veterinary school in the last 10 years and has displayed outstanding accomplishments in veterinary research, private practice,



regulatory services, civic activities, and/or organized veterinary medicine. This award is intended to recognize the immense talent we have entering the profession in our state.

Dr. Travis White of Wessington Springs received the 2014 SDVMA Emerging Leader Award. Dr. White was raised on a ranch just outside of Ashton, ID, about twelve miles from the West entrance of Yellowstone. At a young age living at the ranch, he found his love for caring for animals and knew that one day he would become a veterinarian.

He graduated with high honors from Utah State University with a Bachelor's Degree in Animal Science in 2005. Dr. White received his DVM from Washington State University. He was the President of the Veterinary Business Management Association and was recognized as being an Amstutz Scholar when he graduated in 2009.

After graduation, Dr. White, his wife Nann, and their daughters, ShyAnn, Kimber, Cale, and Hadlee, moved to Wessington Springs, SD and have lived there for the past five years. Two years ago, Dr. White and Nann took over the practice and have been working diligently to keep things running for all the loyal customers of Wessington Springs.

Rabies Titer Results from 2014 SDVMA Meeting: "Higher" Rate of "Low" Titers

Representatives from the South Dakota Department of Health who assisted with testing veterinarians for rabies titers at this year's SDVMA annual meeting reported a higher than usual rate of individuals with low titers. At the 2014 meeting, 26% (7/27) of those people tested had sufficiently low titers that a booster dose was recommended. This is in contrast to lower percentages (10-15%) of low-titered individuals found in previous years.

For the past several years, SDVMA has teamed up with the Department of Health to offer rabies titer testing on a cost basis to attendees of the SDVMA annual meeting. The Centers for Dis-

ease Control and Prevention recommend that veterinarians and staff working in rabies endemic areas (such as South Dakota) have their titer checked every two years. Those with a sufficiently low titer are advised to receive a single booster of rabies vaccine. There is no further testing requirement, as the vaccine is known to sufficiently booster a previouslyvaccinated individual. Keeping current with pre-exposure rabies vaccine simplifies treatment after a known rabies exposure: a vaccine booster is given but there is no requirement for immunoglobulin.

The higher rates of low rabies titers should serve as a reminder for veterinarians to have their titers checked on a biannual basis. The SDVMA will continue to offer this service at their annual meetings, but veterinarians can contact their local providers for this service as well.

Issuing Prescriptions

The Board requires practitioners in South Dakota abide by the AVMA Principles of Veterinary Medical Ethics ..."Dispensing or prescribing a prescription product requires a VCPR; Veterinarians should honor a client's request for a prescription in lieu of dispensing."

Interesting note from Oregon regarding background checks for veterinary licensees

The Portland Tribune July 15, 2014

"New veterinarians and veterinary technicians will have to undergo criminal background checks before they can obtain licenses in Oregon.

The Oregon Veterinary Medical Examining Board decided to put the new requirement into effect immediately, says Lori Makinen, the board's executive director. The board met in Portland over the weekend.

The action will cost applicants an extra \$50 for the check, which is based on the fingerprint files maintained by the FBI and is conducted by the Oregon State Police. Applicants also must pay for live-scan (inkless) fingerprinting, which is offered by 39 agencies in Oregon.

The requirement was prompted by a state audit of 17 health-related licensing boards released in March. The audit by the secretary of state disclosed that the veterinary board was just one of three that did not conduct background checks. The others are Occupational Therapy, and Speech Pathology and Audiology.

According to the audit, the veterinary board had 3,365 licensees at the end of 2013. In 2012, the board issued 248 new licenses and renewed 3,217.

West River Meeting



Dr. Angela Pillatzki started June 22nd as a Board Certified Pathologist from Iowa State University; Dr. Diego Diel started August 22nd from the University of Illinois as a Virologist and researcher in vaccine design and diagnostics; and Dr. Joy Scaria started September 22nd from Cornell as a bioinformatics and bacteriology researcher who investigates diseases that can affect both people and animals.

Ebola Information

The recent cases of Ebola in the United States have increased the need for information and education of the public on what Ebola is and, in the case of veterinary medicine, what impact it has on animals.

The American Veterinary Medical Association (AVMA) is collaborating with the USDA, CDC and other agencies and experts to develop information about Ebola virus and animals and have formed several working groups to address the issue and develop resources. Four working groups of subject matter experts and authorities of oversight have been formed and are in discussions now to help address Ebola virus issues pertaining to animals. Members of these groups include infectious disease specialists, epidemiologists, public health experts, state and federal regulatory agency staff, and private practitioners. Information from the working groups will be released when it becomes available.
