



SDVMA Summer Meeting to Highlight Emergency Medicine, Including Hands-on Procedure Lab

Russ Daly, DVM, SDSU

Jennifer Devey, DVM, DACVECC, will be the featured speaker at this year's SDVMA Summer Meeting, June 5-6, at the Ramkota in Pierre. An internationally known expert in companion animal emergency and critical care, Dr. Devey will speak on several critical care topics Friday morning and lead a hands-on procedure lab in the afternoon.

Dr. Devey is a graduate of the Ontario Veterinary College, University of Guelph. She did an internship and an emergency and critical care residency at the Animal Emergency Center in Milwaukee, Wisconsin and became a Diplomate of the American College of Veterinary Emergency and Critical Care in 1996. She subsequently completed a surgical residency in 2004 studying at several private practices in the USA. Jennifer has been director of emergency and intensive care services at a number of large private referral

practices in Canada and the United States – most recently at Lauderdale Veterinary Specialists in Fort Lauderdale, Florida, where she was the department head of the emergency and critical care service and director of education. She has published over 50 articles and book chapters, is actively involved in research, and is a member of seven professional veterinary organizations around the world. Jennifer enjoys teaching and is actively involved in training interns and residents as well as lecturing and teaching workshops to nurses and doctors.

Topics for the morning session will cover subjects such as making the right decisions regarding critical cases, anesthesia decisions for seriously ill patients, fluid therapy, and how to deal with “Big Dog vs. Little Dog” cases. The afternoon emergency procedures lab will include hands-on practice with placing and managing all sorts of

“tubes”, such as central venous and epidural catheters as well as esophagostomy, tracheostomy, and thoracostomy tubes, just to name a few!

Once again, the Friday afternoon breakout session will feature important updates from industry partners and other topics of wider interest.

The meeting kicks off on Thursday with recreational activities including golf, fishing and trap shooting followed by an evening supper for all participants. The meeting once again coincides with the state veterinary board exam, and a special invitation is made to veterinarians in town to take the boards.

Greetings from your President

Shortly after the last issue of the Vet-Net was published. I was contacted by two veterinarians that had an individual performing equine lay dentistry in their respective practice areas. Both had the same question for me: what do we do? I knew that a complaint could be turned into the South Dakota Veterinary Medical Exam Board, but I honestly wasn't exactly sure how the process works. I called and talked to our state veterinarian, Dr. Dustin Oedekoven. He had a great wealth of information and educated me on the complaint process and how to file a complaint. There is an easy to follow complaint procedure form found on the South Dakota Veterinary Medical Exam Board's website. This form details how to submit a complaint against an unlicensed individual performing veterinary services. Dr. Oedekoven also noted that the Veterinary Exam Board's budget does

not allow them to actively search or seek out these individuals, so it is up to us (veterinarians) to help police our profession. Because if we don't, who will?

In February I had the opportunity to attend a "One Health" meeting put on by the South Dakota Department of Health and the SDSU Extension Office. Dr. Russ Daly played a large part in putting on this meeting. The topic was: "Preserving the Usefulness of Antibiotics: Efforts in Animal and Human Medicine in South Dakota". This was a great learning experience on the various measures the human medical field is doing to decrease antimicrobial use. Going into the meeting, I expected a lot of discussion on MRSA or *C. difficile* resistant infections; however, there was very little on MRSA or *C. difficile*. A large amount of discussion focused on CRE (Carbapenem-resistant Enterobacteriaceae). The

human medical field looks at CRE as the new "super-bug". The reason for so much concern about CRE is the 50% mortality rate for CRE infections!

The legislative session has ended. The two bills the SDVMA was supporting were passed into law. Senate Bill 75 prohibits local governments from enacting, maintaining, or enforcing regulations on certain breeds of dogs. Senate Bill 46 revised certain provisions regarding animal welfare and provides a felony penalty for cruelty to animals. Senate Bill 46 was the result of the hard-work and effort from our state veterinarian Dr. Dustin Oedekoven.

Animal Industry Board

Thanks to the support of a broad coalition of animal, livestock, and agricultural organizations, including the SDVMA, SB 46 was passed by the legislature and signed into law by Governor Dennis Daugaard. While South Dakota has had good and effective laws to deal with cases of neglect, mistreatment, and abuse of animals, this law creates a felony for the most malicious and intentional acts of cruelty. Perhaps more importantly, it builds on the strengths of our current law to provide clear protection for all acts conducted by licensed veterinarians, as well as all usual and customary management practices of animals and for all aspects of the livestock industry.

The Veterinary Medical Loan Repayment Program (VMLRP) is now entering its fifth year. This program is administered by USDA's National Institute of Food and Agriculture (NIFA) and provides loan repayment of up to \$25,000 each year for 3 years for veterinarians with qualifying student loan debt who are willing to work in a designated food animal shortage area. Shortage areas are nominated by each state's chief animal health official, and are then subject to designation as such by the VMLRP program staff. South Dakota was once again given the opportunity to nominate up to 6 shortage areas in South Dakota. NIFA is expected to announce the designated shortage areas and application process within the coming months.

Porcine Epidemic Diarrhea virus (PEDv) has been confirmed in at least 22 South Dakota swine farms as of this writing. As we prepare for the upcoming summer show season, veterinarians are encouraged to participate in planning local swine exhibitions to advise show officials on biosecurity, health certificate requirements, and isolation practices for swine returning home after the show. The pork industry and the American Association of Swine Practitioners have developed guidelines that can be accessed at www.pork.org and www.aasv.org. PEDv is a reportable disease in South Dakota.

The South Dakota Animal Industry Board has modified South Dakota Cer-

tificates of Veterinary Inspection, in part to meet expectations of USDA's Animal Disease Traceability rule (ADT). The new CVIs can be used either for intrastate or interstate movement. Books of continuation forms are also available to list more than 20 animals covered by the certificate. Electronic certificates of veterinary inspection continue to gain popularity. If you write CVIs and have not yet looked at this technology, I'd encourage you to visit with Dr. Susan Reenders, AIB staff veterinarian, about the available options.

If you assist producers who are planning to move livestock to other states for any number of reasons this summer (grazing, show, change of ownership, etc.), please advise them of their responsibility to get CVIs in accordance with the requirements of the state of destination. ADT has caused

some states to change their import requirements to be compliant with the new federal rules, so if you haven't checked with the state animal health official in the destination state recently, be sure to contact them to assure your client is in compliance.

Under the now year-old federal animal identification regulation, veterinarians are to forward CVIs to the state veterinarian's office within 7 days of issuance. If you find this difficult to achieve, try implementing a new habit or policy in your office to send out CVIs on a set day of the week and you'll always have this task completed. Or, consider using electronic CVIs as these are automatically forwarded at the time of issue. Per the ADT rule, veterinarians must keep copies of CVIs for swine and poultry for at least 2 years, and at least 5 years for all other livestock species.

Roy is survived by his grandson, Trappor (Emilee) Masson and their daughter, Rosalee of Rapid City, and his niece, Annette Zink.

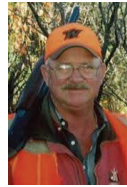
He was preceded in death by his wife, Delpha, one son, Robert and his parents.

AVMA Delegate's Report

Your SDVMA delegates continue to monitor the ongoing on-line debate on changes in AVMA governance. As I reported in the last column, in the AVMA House of Delegates (HOD) it appears that the AVMA members in the state will elect one of the two delegates and the other delegate will be elected by the SDVMA. Terms will likely be 3 or 4 years with a term limit of 2 terms. South Dakota's vote would then be divided between the two delegates. To me this debate has gone on too long and we need to move onto more important governance issues- the

AVMA committee structure. This involves fine tuning and reducing the number of committees and coming up with a better method to appoint members to committees rather than having the HOD select some and the Executive Board select others.

One of our SDVMA members contacted me about FDA's proposed FDR for food animals and wanted to give some feedback. I was able to connect him directly with Dr. Bernadette Dunham, the director of the Center for Veterinary Medicine at FDA. If you have any questions on contacting FDA

or USDA and obviously AVMA, please let us know so we can get you in contact with the right folks.

Dr. Bailey Recognized at Herd Health Conference

This year was the 27th annual Herd Health Conference. The first Herd Health Conference was held in 1988. In 1997, it was renamed the James Bailey Herd Health Conference in recognition of Dr. Bailey's contributions to veterinary medicine in South Dakota.

Bailey joined the SDSU faculty in 1968 as the Extension Veterinarian. He retired in 1985 and was granted the status of Extension Veterinarian Emeritus. He served as the SDVMA Secretary/Treasurer from 1972-1985, and was the Executive Director of the SDVMA from 1985-1996.

Dr. Bailey's distinguished career includes numerous accomplishments.

In 1969, Bailey was one of the original Extension personnel to compile the fact sheets that became the present Pork Industry Handbook. He contributed information on respiratory diseases and arthritis in swine. He was honored by the American Association of Extension Veterinarians as the Veterinarian of the Year and SDVMA Veterinarian of the Year during his career.

He served on the SD Hog Cholera and Pseudorabies Eradication Committees. He was a member of the SD Livestock Foundation from 1970-96.

He served on the Livestock Conservation Institutes Parasite Committee from 1979-81. Dr. Bailey received the SDPPC Distinguished Service Award in 1976 and was named an Honorary Pork Producer.

Dr. Bailey was a charter member of the American Association of Swine Practitioners in 1969. He served as the organization's first secretary in 1972 and as the president in 1980-81. He was granted the distinguished Howard Dunn memorial Award for extraordinary service to veterinary medicine and the Swine industry in 1986.

Dr. Bailey served as a member of the American Veterinary Medical Association's House of Delegates through the 1970's and on the Council on Biologics and Therapeutic Agents

during the 1980's. Iowa State University College of Veterinary Medicine presented Dr. Bailey the prestigious Stange Memorial Award for distinguished alumni in 1984.

Dr. Bailey resides in Brookings.

The ADRDL has been busy doing a lot of testing and research for Porcine Epidemic Diarrhea Virus (PEDV) and Porcine DeltaCoronavirus (PDCoV). Real-time PCR is available for both PEDV and PDCoV. The fluorescent antibody test for tissue sections can also be performed using the PEDV monoclonal antibodies produced at the ADRDL. In addition, two recently funded National Pork Board Grants are supporting the research related to PEDV and are entitled, "Duration and level of PEDV neutralizing antibodies for clinical protection using feedback protocols" and "PEDV diagnostic approaches to assess sow immunity and piglet protection". We appreciate the opportunity to work with veterinarians in the field on these specific projects.

For new personnel, Dr. Angela Pilatzki will be joining us on June 9 of this year. Dr. Pilatzki is a Board Certified Pathologist and has spent the last five years as a Clinician/Veterinary

Diagnostician in the Veterinary Diagnostic Laboratory at the College of Veterinary Medicine at Iowa State University.
